Presentation:

Phil B from the ISO - provided an updated on the ISO and Lifeline Appeal as part of the *Global Awareness initiative Giving Hope a Voice*. Vision - global resource for recovery and help groups carry the message.

- Finance update - SAA has recovered from 2022 financial crisis where \$250,000 shortfall, incredibly donations arrived and ISO broke even!
- Executive Director and Finance Manager stepped down. Two positions were not replaced due to the shortfall in funding.
- Life-line (monthly donations) and one-off donations are declining. Lifeline donations keep SAA stable. Group donations have dropped.
- To prevent crisis - a \$15,000 donor match challenge has been established

- 2023 40+ public information and communication with professional communities. Example projects
 - Google ads, state conferences, national (USA) conferences, mailings to professionals (USA), presentations to non-saa orgs, newspaper ads.
 - Have a library of documents/ templates
- Critical projects - improved meeting search page on international website, *getting lots of complaints. Volunteer level has been used, but it needs to be professionally re-written.
- Want to put meeting search on SAACConnect, which also has chat rooms
