Current Bylaws:

IX. Acceptance and use of Donations

- A. *The Intergroup* may accept donations from any SAA member, meeting, group or Area. Donations are not accepted from outside (non-SAA) persons or meetings.
- B. Donations are to be used or distributed for SAA women members only, or for events which include and support women.
- C. *The Intergroup* may pay for recovery events and resources, and then assign oversight for the event or resource to another partner SAA organization (such as the Women's Outreach Committee), for benefit of SAA women members only.

- i. Tabled a motion to permit donations to the ISO.

add section *D. The exception to section "B" is, donations may also be made to the International Service Organization [ISO] of SAA.* or as a second sentence in item B: *The only exception to this is donations may be made to ISO of SAA, Inc.*

- ii. Tabled motion changing Bylaws section IX subsection B to say, donations can be used "*to support women and gender minorities*" instead of "*to support women*". Discussion:

1. Does gender minorities include non-binary folks?
2. Are transmen included?
3. Language could be "anyone who self-identifies as a woman" which may exclude gender non-binary folks
4. We should support local groups in their definition of what women/gender minorities are welcome. So, WIG going with more inclusive language can allow for local groups to decide.
5. This group was made for women, there could be an LGBT intergroup too, so our funds should go to support women.
