I move that the bylaws be changed to remove all references to the Board of Directors, and Directors themselves; by removing all of the following (in **BOLD RED**):

**IV. Officers**

...

- B. **The Board of Directors shall be comprised of at least one officer; it shall also include at least one additional, At-Large Director(s), for a total of no more than 5 Directors in all.**

D. ... **Director’s term of office shall be two years, but no later than the second service year elections.** ... [Officers] **and Directors** [may be re-elected following their term.]

IX. Acceptance and use of Donations

**D. All grants and donations approved during regular SAA Women’s Intergroup meetings must also be approved by the Board of Directors for carrying out the purpose described in Section II.**

X. Amendments to *The Intergroup* Bylaws

**C. All changes to the Bylaws passed during regular SAA Women’s Intergroup meetings must also be approved by the Board of Directors before they take effect.**

3. **Motion suggested by Dan B: Changing how we disband, and where the money goes.**

I move that the following change be made to our Bylaws:

Replace the entire section **XI. Disbanding The Intergroup;**

This section now reads:

**XI. Disbanding The Intergroup;**

**A. If *The Intergroup* disbands, all money remaining after payment of outstanding debts will be donated to the ISO**

To be replaced with:

**XI. Disbanding The Intergroup;**

**A. The Intergroup may ratify disbanding itself only if such a motion was announced on the google group at least fourteen days before it is scheduled for a vote in a meeting.**

**B. If *The Intergroup* disbands,-after paying all outstanding debts, *The Intergroup* shall donate any remaining assets wherever possible to an SAA organization or organizations having similar objectives. This should be completed within one year of the final meeting.**

4. **Motion suggested by Dan B and others:**

**I move that the chair appoint a committee of volunteers to investigate changing our format into a “real” Intergroup, with registered meetings (those sharing our mission) and no more than one voting member per registered meeting at each business meeting (following the Telemeeting Intergroup model).**
