Survey Discussion: though we only had 8 responses, the survey points to a couple of conclusions:

Reach: we prefer broad reach, experiences that speak to as many people as possible

Motivation: no clear GC on whether we want motivational vs. educational writings

Focus: we overwhelmingly agreed that we want literature on sex addiction vs. other 12-step programs or 12-step generic literature.

Segment Length: we prefer shorter segments that can be completed in one meeting.

Stories vs. Solution: no GC on this topic

Conference Approval: we overwhelmingly don't care if the literature is conference approved or not.

5th Tradition: we overwhelmingly agreed that it's sufficient if the meeting focuses on the newcomer even if the literature does not.

Top Three: we asked people which of the above responses mattered to them the most:

Focus

Stories v. Solution

Reach

Discussing the results, we agreed that the GC seems to point to continuing on with daily meditations. By the end of the meeting, we had identified the following books and will continue to make weekly announcements asking for people to nominate any additional books. We had a group discussion about the priorities of this group in selecting our next book. Ideas started to gel around certain topics.... Should the book be encouraging vs. educational? Short or long segments? Restricted to S-literature or would any 12 step program be acceptable? If restricted to S-literature, should it be restricted to SAA literature? If restricted to SAA, does it have to be conference approved? Should it focus on the newcomer? Are stories OK or too triggering? It was clear that we were getting mired in the discussion of these topics without ever discussing a single book.
