Now is the time that we celebrate **milestones** in sobriety. Does anyone have 30 days? 60 days? 90 days? 6 months? 9 months? 1 year? 18 months? Multiples of years? How about 24 hours?

Now let's go around for **introductions**. It is the custom of this group for members to share their first name only, where you're from, how you're feeling, 2 of your inner circle behaviors, and your current length of sobriety from these behaviors.

Regarding sponsorship: We, as a group, believe that completing step work with a sponsor is an integral part of gaining and maintaining sexual sobriety. If you do not have a sponsor, or have questions about what a sponsor is, please talk to someone after the meeting.

Meeting Format: This is a meeting of Sex Addicts Anonymous. We use only SAA approved literature. The format for this meeting varies. The first week of the month is a step meeting, the remaining weeks are a topic meeting.

(Based on the week of the month: Trusted servant chooses from A or B and reads as follows:)

- A. **Step Meeting (First week):** Today this is a 12-step meeting of SAA. The step we will read is based on the month of the year. We will read Step _____, pg. _____ from the SAA Green Book *(Read Step # for the current month – i.e., if it is February, we will read Step 2, if it is November, we will read Step 11, etc.)*.

Now the meeting is open until 45 minutes past the hour for discussion. You may comment on the step we read or the step you are working on. Please limit your share to 5 minutes and request we stay focused on the solution rather than the problem. Who would like to begin?

- B. **Topic Meeting (Remaining Weeks):** This is a Topic Meeting of SAA. Now it's time to read from the SAA literature "_____". I'll start on page _____ (Section) and then pass to the next reader.

Now it's time for discussion until 45 minutes past the hour. You may comment on the Topic we just read, or you may talk about how you are doing now. Please limit your share to 5 minutes and request we stay focused on the solution rather than the problem. Would anyone like to share?

(For trusted servant—generally about 15 minutes before the top of the hour, say “It’s now time to close the meeting”).

It's now time for the **7th Tradition** which states that every SAA group ought to be fully self-supporting declining outside contributions.
